**PLEASE NOTE: ALL HUNTERS WITH AN ADULT HUNTING LICENSE(16 YEARS AND OLDER) MUST PAY A \$35.00 HUNT APPLICATION FEE FOR THE 2009/2010 SEASON (IN ADDITION TO REGULAR ANNUAL MEMBERSHIP FEE) WITH THIS FORM.**

**Important-**All applications must be received at Valley Waterfowl at least *14 days prior* to the selected hunt dates. Also a completed *release of liability form* must be completed and submitted for each hunter, with each hunt application. Any multiple applications received by any hunter for the same date and any incomplete applications or release of liability waivers will disqualify the hunter for the dates selected. Each hunter *must indicate* the name and information of the second hunter at the time of application. If no second hunter is listed, the hunter will not have the opportunity to bring a second hunter, and they will be assigned a single seat in the blind. *Applicants who are not current members of Valley Waterfowl may submit their membership fees with this application.*

**Decoys-**Each blind is adequately equipped with both duck and goose decoys. The decoys were purchased with funds obtained through donations to Valley Waterfowl. We have decided to equip the blinds with decoys this year for the convenience of our members. Please take extra precautions to not shoot at low flying birds in order to avoid striking the decoys. Also, please help us by reporting decoy theft and trespassers. If the decoy program is a success this year, we will do our best to continue the program in the future.

**Rules of Conduct**

- *The only people allowed in the field and on the property are current Valley Waterfowl Members*
- *People who are on the property without permission (trespassing), are subject to prosecution.*
- *Overnight camping is not permitted on the property.*
- *Hunters may not access the hunting areas until an hour prior to shooting time.*
- *Each hunter will only access and use their designated blind and seat.*
- *To ensure the integrity of the dikes and maintain natural cover, the hunters will avoid walking on the dikes whenever possible, and will traverse to and from the blind through the water.*
- *No alcohol will be allowed on the property and no hunters who have consumed any alcohol will be allowed into the field.*
- *Skyscraping, shooting prior to shoot time, and shooting after shooting hours will not be permitted.*
- *Avoid low shots that may strike the decoys.*
- *Report decoy theft and trespassers.*
- *Upland game hunting on the property is prohibited.*
- *Pick up your trash and spent shell casings.*
- *Vicious and uncontrolled dogs are not allowed.*
- *Members/Hunters will abide by all fish and game laws as well as all other state and federal laws.*
